

**Connecticut Lottery Corporation**  
**\$30,000 Summer Sizzler Promotion**  
**Official Rules**

**I. PROMOTION RULES**

- A. These Official Rules ("Rules") govern the \$30,000 Summer Sizzler Promotion ("Promotion") sponsored by the Connecticut Lottery Corporation ("CT Lottery") with drawing services provided by Scientific Games LLC ("SG").
- B. Participation in the Promotion constitutes a player's full and unconditional acceptance of and agreement to abide by these Rules, the Terms of Use, and the decisions of the CT Lottery, including the CT Lottery's interpretation of these Rules and the Terms of Use and its exercise of discretion, which will be final and binding in all matters.

**II. PROMOTION DESCRIPTION**

The CT Lottery will conduct the Promotion according to these Rules. During the Promotion, the CT Lottery is highlighting its six (6) active \$30 scratch games: (1) Win Big (Game #1816); (2) \$500,000 CA\$HWORD 2<sup>nd</sup> Edition (Game #1800); (3) Millionaire Maker (Game #1774); (4) \$1,000,000 Titanium (Game #1711); (5) \$1,000,000 Extreme Cash (Game #1699); and, (6) Diamonds & Gold (Game #1677) (collectively, "Games" and individually, "Game").

There will be one (1) promotional drawing ("Drawing") on a designated date (see Section III). During the Drawing, thirty-one (31) winners will be randomly selected from all eligible entries for that Drawing to win a prize (See Section VI) for prize details).

**III. PROMOTION PERIOD & DRAWING SCHEDULE**

The Promotion will begin on July 01, 2025 at 0:00:00 and end on July 31, 2025 at 23:59:59 ("Promotion Period").

The Drawing will be held in accordance with the following Drawing Schedule:

All times referenced are Eastern Time.

\*Drawing date and entry deadline date is subject to change at the discretion of the CT Lottery. Any changes will be announced on the CT Lottery's 2nd Chance App and website at least ten (10) calendar days prior to the scheduled entry deadline date.

The Drawing will be conducted by SG at their offices at 1500 Bluegrass Lakes Parkway, Alpharetta, Georgia, 30004. Drawing location is subject to change at the discretion of the CT Lottery.

**IV. WHO CAN ENTER**

The Promotion is only open to players who are at least eighteen (18) years old, have registered\* for a CT Lottery 2nd Chance account, and purchase or otherwise lawfully obtain a non-winning ticket for one of the six active \$30 scratch games (Game #1816, Game #1800, Game #1774, Game #1711, Game #1699, or Game #1677), during the Promotion Period.

*\*Registration will require entry of a player's correct full name, date of birth, street address, city, state, zip code, last four (4) digits of their Social Security number and telephone number. As part of the CT Lottery's registration process for this Promotion, the CT Lottery uses third-party identity authentication services to confirm that the player is at least eighteen (18) years old. If a player's identity cannot be confirmed, additional steps for manual confirmation will be provided.*

The following individuals are not eligible to enter or win a prize in the Promotion:

- A. CT Lottery employees or CT Lottery Board Members;
- B. Persons or employees of business entities issued occupational, vendor, or affiliate licenses by the Connecticut

Department of Consumer Protection in connection with the CT Lottery's operations;

- C. Persons or employees of business entities prohibited from playing CT Lottery games by virtue of any agreement with the CT Lottery;
- D. Immediate family members related by blood, adoption, marriage, domestic partnership, or civil union to a person described in (A), (B), or (C) above residing in such person's household; and,
- E. Any person found to be in violation of any of these Rules, the Terms of Use, or any other applicable law, regulation, procedure or rule.

## **V. HOW TO ENTER**

- A. To participate in the Promotion, players must submit their entries via the CT Lottery's 2nd Chance App or website ([ctlottery.org/secondchance](https://ctlottery.org/secondchance)). A player must be logged in to their CT Lottery 2nd Chance account to submit an entry. No other method of entry will be accepted.
- B. Only non-winning Game tickets will be accepted as valid entries for this Promotion.
- C. Any non-winning Game tickets mailed or hand-delivered to the CT Lottery will not be entered in any Drawing. The CT Lottery may, in its sole discretion, return any non-winning Game tickets improperly delivered to the CT Lottery to the original sender by mail.
- D. To enter the Drawing, the player must correctly enter both the front number and the back number found on each eligible non-winning Game ticket. The CT Lottery is not responsible for any data entry errors.
- E. Each eligible non-winning Game ticket may only be entered once. An attempt to electronically submit a Game ticket that has already been submitted will generate an error message informing the player that the Game ticket has already been submitted and may not be resubmitted.
- F. CT Lottery is not responsible for any claims, injuries, losses, or damages arising from or related to improperly delivered non-winning Game tickets, entries submitted incorrectly, or entries received outside of the established Entry Deadline Date for the Drawing.
- G. Players must retain their non-winning Game ticket(s) as proof of eligibility. In order to claim a prize, players will be required to submit the original non-winning Game ticket for validation. The player must legibly print their name, address, city, state, zip code, and telephone number on the back of the original non-winning Game ticket. The Game ticket must include only one (1) name. Failure to submit the original non-winning Game ticket will result in disqualification.
- H. A player may enter the Promotion more than once, as long as each entry is based upon a different non-winning Game ticket. No player may win more than one (1) prize in the Drawing.
- I. A player may submit a maximum of fifty (50) tickets for entry into this Promotion or any other promotion offered on the CT Lottery's 2nd Chance App or website per day. A day is defined as that period of time which starts at 12:00:00 a.m. Eastern Time and ends at 11:59:59 p.m. Eastern Time.
- J. To qualify for the Drawing, an entry must be received by the Entry Deadline Date for the Drawing. Entries received after the Entry Deadline Date will not be entered into the Drawing.
- K. All entries are subject to validation by the CT Lottery and/or SG.
- L. Each non-winning Game ticket submitted in this Promotion must have been purchased from an authorized CT Lottery Retailer, must be intact, and must not be mutilated, altered, reconstituted, or tampered with in any manner.
- M. Any Game ticket determined to be from a missing or stolen pack of Game tickets or found on the stolen ticket report will be deemed ineligible, and the entry will be disqualified.

- N. The CT Lottery is not responsible for the electronic misdelivery, late delivery, or failure to receive Game ticket information entered electronically, and the risk of loss remains with the player regardless of the cause of transmission failure.

## **VI. PRIZE DETAILS**

### **A. Drawing Prizes**

- One (1) winner selected in the Drawing will be awarded a \$30,000 prize.
- Thirty (30) winners selected in the Drawing will each be awarded a \$1,000 prize.

During the Drawing, thirty-one (31) winners and fifty (50) alternates will be randomly selected from all eligible entries for the Drawing. If a selected winning entry is disqualified, the next eligible alternate will be awarded the prize. The odds of winning a prize in the Drawing depend on the number of eligible entries received for the Drawing.

## **VII. WINNER ELIGIBILITY, NOTIFICATION & VERIFICATION**

- A. Winners will be notified in writing by the CT Lottery. The CT Lottery will send each winner a congratulatory letter via certified mail to the address associated with the winner's CT Lottery 2nd Chance account with instructions for claiming their prize.
- B. In order to claim their prize, winners must submit a completed Eligibility Form, proof of age, and their original non-winning Game ticket to the CT Lottery no later than ten (10) business days after receipt of the congratulatory letter.
- C. As a condition of receiving a prize, the CT Lottery requires the winner to submit a completed Eligibility Form and acceptable proof of age to the CT Lottery. An incomplete Eligibility Form will not be accepted by the CT Lottery. The CT Lottery is under no obligation to notify a winner that their Eligibility Form is invalid. At any time, the CT Lottery may require the winner to present valid proof of identity to confirm that the winner is the registered 2nd Chance account holder that submitted the winning entry and/or that the winner is eighteen (18) years of age or older. A winner who is unable to present valid identification upon request is ineligible to receive a prize.
- D. If a winner fails to submit the completed Eligibility Form, proof of age, and/or the original non-winning Game ticket within the allotted time, fails to comply with these Rules, the Terms of Use, or any other applicable law, regulation, procedure or rule, or is otherwise deemed ineligible by the CT Lottery, the winner will be disqualified and the prize will be awarded to the next eligible alternate.
- E. Each winner, upon submitting the completed Eligibility Form, is responsible for all applicable federal and state taxes associated with the prize(s) won. CT Lottery will report winnings and withhold federal and state taxes in accordance with federal and state laws and regulations. CT Lottery will provide a Form W-2G to each winner, as applicable.
- F. The CT Lottery will not award a prize to a winner who owes any debt: to the CT Lottery; to the State of Connecticut that is collected through the CT Lottery; or to a third-party that is collected by the State of Connecticut through the CT Lottery. The CT Lottery will allow the winner seven (7) business days from notification of debt to satisfy any such debt and provide proof, in the CT Lottery's sole discretion, that the debt has been fully satisfied. If the debt is not satisfied, then the winner will be disqualified and the prize will be awarded to the next eligible alternate.
- G. All winners are subject to verification by the CT Lottery and/or SG and may be disqualified if eligibility requirements are not met.
- H. Prizes will be fulfilled by CT Lottery via a check sent to the mailing address associated with the winner's CT Lottery 2nd Chance account after the winner's eligibility has been verified.

## **VIII. GENERAL TERMS**

- A. The Drawing will be conducted in accordance with CT Lottery official drawing procedures.

- B. Alternates are not prize winners. An eligible alternate may be awarded a prize if the selected winner is ineligible to claim the prize, fails to claim the prize, or is otherwise disqualified. Selected alternate entries will be used to replace disqualified entries in the order they are drawn. An alternate entry that replaces a disqualified entry will be awarded the prize that the disqualified entry was selected to receive.
- C. Each winner's name, hometown, and prize won will be published to the CT Lottery's 2nd Chance App and website after their eligibility has been verified. Upon claiming the prize, a winner may request that their name be excluded from the website.
- D. The CT Lottery reserves the right, in its sole discretion, to modify, suspend, postpone, or cancel, with or without notice, any Drawing, the Game(s), or this Promotion.
- E. The CT Lottery's decisions as to the administration and operation of this Promotion and the selection of winners are final and binding in all matters related to this Promotion.
- F. Winners are responsible for all federal, state, and local taxes associated with prize(s).
- G. Prizes are not assignable or transferable. The CT Lottery reserves the right to substitute prizes of equal or greater value.
- H. Participation in the Promotion is subject to all applicable Connecticut and federal laws and regulations, and CT Lottery procedures and rules, including but not limited to, the Official Procedures for All Scratch Games, these Rules, and the Terms of Use. Applicable laws, regulations, procedures, and rules, including these Rules, are subject to change without notice and participation in this Promotion is subject to the most current laws, regulations, procedures, and rules in effect at the time.
- I. The CT Lottery, the State of Connecticut, and their respective agents, directors, officers, officials, and employees, are not liable for: late, lost, misrouted, garbled, distorted, or damaged entries, Eligibility Forms, original Game tickets, notifications, other communications, or transmissions; telephone, electronic, hardware, software, network, internet, or other computer, or communications-related malfunctions or failures, including but not limited to, lost Drawing entries, or any canceled Drawing, caused by any malfunction or through operator error; Promotion disruptions, any printing or typographical errors in any materials associated with a Promotion; entries, claims, or other communications not received by the CT Lottery or that are lost in the mail or delivered elsewhere, or are electronically misrouted or misdirected; discontinuation of any Drawing, event, or the Promotion by the CT Lottery; failure by a winner to submit a valid Eligibility Form to the CT Lottery, thereby rendering the winner ineligible to receive a prize; or other injuries, losses, or damages arising from, related to, or caused by the Promotion, or any claims arising from or related to the acceptance, possession, or use of any prize or any other item of value offered by the CT Lottery.
- J. This Promotion is void where prohibited by law.
