

**UConn Basketball Tickets Giveaway**  
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU MUST BE 18 YEARS OF AGE OR OLDER AND A LEGAL RESIDENT OF CONNECTICUT AT TIME OF ENTRY TO BE ELIGIBLE.**

3. Submit your entry by 4:00 pm E.T. today.
